Staffed Programs

Individual Advocacy

Advocates share knowledge and experience to help families from birth or the time their child is diagnosed with a developmental disability and through the entire life cycle. Knowledgeable, experienced, connected advocates help individuals access education, housing, employment, financial assistance, direct care staffing, Medicaid, Medicare, Social Security, and other supports they and their families need.

Systems Advocacy

Volunteers and staff actively participate on local and state government affairs committees, disability policy work groups, and consumer advisory committees to promote public policies that support self determination and community life for people with intellectual and developmental disabilities.

Programs and Services Operations

The Arc NW operations depend on funding that is acquired through various sources including member dues, donations, memorials, bequests, fundraisers, contracts, and grants. Funds are used for operations that promote best practices for people with intellectual and developmental disabilities. Over 90% of every dollar provides services.

Volunteer Supported Programs

The Arc Athletic Program

Arc volunteers fundraise, organize, coach, and chaperone events and trainings for participation in Special Olympic events. Sports training in 2017-2018 included: basketball, softball, swimming, bowling, soccer and poly hockey. The Arc NW office manager and program services assistant support these activities.

Bowling

Since The Arc began volunteers have organized bowling leagues as both an Athletic Program sport and the enjoyment of the game. Volunteers provide bowling opportunities for individuals with intellectual and developmental disabilities on Saturday mornings and afternoons.

Just Fun Club

Arc volunteers organize monthly activities for adults with intellectual and developmental disabilities, 16 years and older. Activities include: hotdog roast, monthly dances (Halloween, Country Western, Hawaiian Lau, Valentines, St. Patty's, Chicken Dinner), an ice cream social, and a semi-formal Christmas dinner dance. The Arc NW office manager and program services assistant support these activities.

Volunteer Operated Fundraisers

The Arc NW is known for being reliable, effective, and responsive to the needs of individuals with intellectual and developmental disabilities. This reputation is the result of effective fund development needed to operate an office of knowledgeable professionals to meet the needs of our members and the community at large.

Annual Dinner Dance & Annual Golf Outing

The continued success of the Annual Dinner Dance and Golf Outing are the direct result of many hard working dedicated volunteers. Funding from these events support The Arc NW's advocacy services.

Athletic Program Fundraisers

Volunteers spend countless hours throughout the year raising funds through Millionaire Parties and a Bowl-A-Thon to pay for uniforms, gym, and tournament fees.

FINANCIAL REPORT

The 2017 Financial Statements (audit) were completed by Cole, Newton and Duran, Inc. and will be available for review after June 13th, 2018. The Arc NW operates within the calendar year, January through December. The board of directors approved the 2017 budget which included funding to add a development director and development software. Beth Kohler was hired as the new Development Director on January 28, 2018 and Bloomerang software was purchased in April 2018. December 2017 Profit & Loss report indicates \$863,070.87 income and \$655,648.91 expense resulting in a year end surplus of \$207,421.96.

THE YEAR IN REVIEW

Improving Lives

INDIVIDUAL ADVOCACY

The Arc assisted 6,027 contacts in 2017 through one on one consultations, public trainings, and information sessions on important issues that affect the lives of individuals with intellectual and developmental disabilities and their families. Navigating complex service systems to assure entitlement supports for person centered services from local school districts, Medicaid Providers, Social Security Administration, Department of Human Services, Michigan Rehabilitation Services, etc.

SYSTEMS ADVOCACY

The Arc of Northwest Wayne County actively participates on the Howell Group, The Arc Coalition of Wayne County, The Arc Michigan Conference of Executive Directors, Michigan Special Education Advisory Committee, The Arc Michigan Government Affairs Committee, The Arc Michigan Education Committee, Detroit Wayne Mental Health Authority Board Meetings and Committees, Michigan Department of Community Health Developmental Disability Practice Improvement Team, and other pertinent local and state committees. Members and staff attend a variety of training seminars and conferences to stay abreast of best practices through state of the art policies and programs. In addition, The Arc of Northwest Wayne County staff presented information about relevant topics at local and state organization's conferences and training sessions.

LEKOTEK

The Arc Lekotek program is an affiliate of the National Lekotek Center in Chicago, Illinois. In 2017, The Arc Lekotek program had 453 contacts with children with intellectual and developmental disabilities, family members and friends through individual and group play sessions in 2017. The Arc's Lekotek Play Leader, Lana Richardson, facilitated fun interactive typical childhood play for children with special needs. Families enjoyed access to an inventory of hundreds of typical and adapted toys during each scheduled Lekotek play session and then select toys to borrow for fun at home. Lana Richardson also provided parents consultations regarding their child's play and interactive abilities and information about other services and supports for their family's unique needs. Lana is trained and certified by the National Lekotek Center.



JUST FUN CLUB

174 Just Fun Club (JFC) members participated in monthly events, including dances and community outings. Each year the committee plans new outings and experiences for the participants including the Annual Kickoff Hot Dog Roast in September, the Ice Cream Social, Holiday Dinner and Spaghetti Dinner Dance. Jackie Norris is the Just Fun Club Committee Chairperson.

ATHLETIC PROGRAM

The Arc Athletic Program volunteers provide sport activity opportunities to adults with intellectual and developmental disabilities. Sports activities include; bowling, swimming, basketball, track and field, softball, team handball, soccer, and poly hockey. Janice Bearden is the Athletic Program committee chairperson coordinating the volunteer coaches and, chaperons, fundraisers, venues, practice schedules, Area and State tournaments for 149 athletes with disabilities.

AFTER I'M GONE PROJECT

The After I'm Gone program had 596 contacts that provided important information and guidance on subjects such as; housing, special needs wills and trust, advance funeral planning, alternatives to guardianship, writing a letter of intent, and other topics to future planning. Michelle Driscoll, Advocacy and Community Resource Director manages the After I'm Gone program.

SELF-DETERMINATION / FISCAL INTERMEDIARY SERVICES

Fiscal intermediary services were provided to 160 people participating in the Community Living Services, Inc. Self Determination Voucher Program in 2017. Fiscal Intermediary Services help individuals live self determined lives; they choose where and with whom they live and decide if they want to receive direct cares support from either a staffing agent or directly hire their staff. An annual audit is conducted to assure that Fiscal Intermediary Services up hold Medicaid and Social Security requirements through state and federal generally accepted accounting principles.

GAIN - GUARDIANSHIP ALTERNATIVES INFORMATION NETWORK

GAIN had 349 contacts that provided information about the legal alternatives to guardianship for adults with intellectual and developmental disabilities. GAIN is an information and referral network, promoting Self-Determination through the legal alternatives to guardianship including: power of attorney for healthcare, patient advocate, joint bank accounts, power of attorney for finances, trustee, conservator, representative payee, etc.

INFORMATIONAL MEETINGS

The Arc provided monthly meetings on a variety of topics including Social Security, Housing, Respite Care, Home Help, Special Education, Alternatives to Guardianship, Person Centered Planning, Self-Determination, Detroit-Wayne County's Managed Comprehensive Provider Network, and other topics of interest to members and the community.

NEWSLETTER

Nine issues of "Inside The Arc" were published and mailed monthly to 435 individuals, families, and Organizations. Newsletters were also available to nonmembers on The Arc NW web site, thearcnw.org Fliers, brochures, and informational documents were distributed throughout the year sharing information and announcing educational and/or recreational opportunities for individuals and their families.



WEB SITE/SOCIAL NETWORK

The Arc NW provides valuable information 24/7 regarding topics that affect our mission, vision, and position statements on its website www.thearcnw.org and Facebook page. Monthly newsletters are mailed to members and current and past editions are also available on the website.

UNITED WAY for Southeastern Michigan

United Way continued the contract with The Arc Collaborative for Southeast Michigan in 2017 with a focus on services that promote financial stability. The Arc Collaborative members include The Arc of Northwest Wayne County and the Arcs of Western Wayne County, Dearborn/Dearborn Heights, Detroit, Downriver, Macomb and Oakland Counties with The Arc Michigan acting as the lead fiduciary. The Arc Collaborative meetings are held at The Arc of Northwest Wayne County.

FUNDRAISING

2017 organizational fundraising events included the Dinner Dance, Golf Outing, 4- Millionaire Parties, and a Bowl-A-Thon. The dedication and hard work many fantastic volunteers made the 2017 events successful once again!

GOVERNMENTAL AFFAIRS

Public policy, its oversight and development, is an important role of The Arc NW as it pertains to the well being of individuals with intellectual and developmental disabilities and their families. The Arc NW has a volunteer governmental affairs committee as one of the standing committees to the board of directors. In 2017, Arc staff and volunteers met with local and state legislators to promote public policy that supports the needs of people with intellectual and developmental disabilities as well as The Arc NW's vision and mission. The Arc NW Jean Walsh, government affairs committee chairperson, Kathy Pfuhler, board member, and Christine Lerchen, executive director participated in the 2017 Disability Policy Seminar in Washington, D.C. promoting The Arc NW vision and mission to members of Congress.
